Paul Kelly is Professor of Political Theory at the London School of Economics and a former Pro-Director of LSE. He is the author and editor of sixteen books, edited collections, and published numerous scholarly articles. His interests range across political theory and philosophy and the history of thought. He has edited and co-edited the Journals Utilitas and Political Studies and cofounded Political Studies Review. His most recent books are Political Thinkers (with David Boucher) Oxford 2017, Conflict, War and Revolution, LSEPress 2021 and he is currently working on a book entitled Against Post Liberalism for Polity Press

He is the Academic and Teaching Convenor for the Law Modules at EISPS. Dr Spano is the Director of the UCL China Centre for Politics, Law and Culture. Dr Spano is also a member of the Centre for Commercial law and of the Centre for Law and Governance in Europe at UCL. Dr Spano is a Fellow at the Centre of European Law at King's College London and at the Asian Institute of International Financial Law (AllFL) at the University of Hong Kong.

From 2009 to 2012, he was a Research Fellow at the School of Law of King's College London. In April 2009, he was awarded with the European Commission's EU-China Science and Technology Fellowship Programme. In this respect, from 2009 to 2012, he conducted research in academic institutions in mainland China and Hong Kong in the areas of WTO Law, Competition Law and Chinese Law. From 2009 to 2011, he was Research Fellow at the School of Law of the Tsinghua University of Beijing.
